

Normes i llista de llibres per a la redacció de l'assaig

A. Normes per a la selecció de llibres

1. Un llibre en anglès de la secció D (llibres en negre) val dos punts. Un llibre en català o castellà de la secció D (llibres en verd) val un punt. L'assaig s'ha de basar en una selecció de llibres de la secció D que sumi almenys vuit punts.
2. La selecció de llibres no pot incloure dos llibres amb el mateix autor.
3. Almenys la meitat dels llibres seleccionats han de tenir autors estrangers.
4. S'han de triar llibres d'almenys quatre seccions.
5. El màxim nombre de punts de llibres d'una mateixa secció és dos.
6. La selecció de llibres és personal i no requereix assessorament ni aprovació del responsable de l'assignatura.
7. No cal comprar cap llibre: els llibres seleccionats es poden sol·licitar a aqa@urv.cat.

B. Normes sobre la preparació i lliurament de l'assaig

8. La redacció i presentació de l'assaig és una activitat individual d'avaluació de l'assignatura Macroeconomia Monetària.
9. L'assaig s'ha d'enviar en format pdf a l'adreça aqa@urv.cat.
10. El lliurament de l'assaig s'ha de fer abans del 18 de juny de 2025.
11. L'incompliment de qualsevol de les normes de les seccions A i B comportarà la no avaluació de l'assaig.

C. Normes sobre la redacció de l'assaig

12. L'assaig s'ha de redactar, tot ell, en un dels tres idiomes següents: català, castellà, anglès.
13. L'assaig ha d'incloure una portada on s'indiqui el títol de l'assaig, el nom de qui l'ha redactat, la data de lliurament de l'assaig i els llibres seleccionats (autors, any de publicació i títol).
14. L'assaig ha d'estar lliure d'errors ortogràfics o gramaticals. Comes, punts i comes, i punts s'han d'emprar correctament.
15. L'assaig ha de respectar les normes de redacció de treballs acadèmics (com, per exemple, s'especifiquen en la guia d'elaboració del treball de fi de grau de l'FEE de la URV del present curs acadèmic).
16. S'ha d'evitar l'ús de paraules, termes o expressions redundants: en la redacció de cada frase no ha de faltar ni sobrar cap paraula.

17. En la redacció s'ha d'evitar l'estil florit (abús d'adjectius), barroc (ús de metàfores, construccions recargolades, expressions llargues o ambígues) i l'ús de paraules innecessàries. Es recomana un estil directe, amb frases curtes i estructura subjecte-verb-predicat-complements.
18. L'assaig s'ha de redactar amb una font (Times New Roman, per exemple) amb mida 12 i almenys amb 16 punts d'espai entre línies.
19. Cal deixar una línia en blanc entre paràgrafs.
20. Els paràgrafs s'han de justificar a la dreta (com es fa en aquest document).
21. L'assaig ha de constar de quatre seccions, numerades d'1 a 4.
22. En la primera secció (que ha de tenir almenys sis pàgines) es resumeix cada llibre. Es tracta de descriure les idees més destacables de cada llibre i les aportacions principals que s'hi fan. Es pot organitzar la secció en subseccions, una per cada llibre.
23. En la segona secció (que ha de tenir almenys tres pàgines) es fa una reflexió crítica global de les idees identificades en la primera secció. No es tracta de fer una reflexió crítica de cada llibre sinó, en la mesura del possible, de tots ells alhora, tot relacionant les idees d'un llibre amb les dels altres. L'objectiu de la secció és relacionar les idees dels llibres triats i valorar la seva vàlua amb criteris objectius (consistència lògica, compatibilitat amb els fets...). La reflexió crítica pot incloure:
 - arguments a favor i en contra de les idees de la primera secció;
 - una anàlisi de la seva consistència (si les idees desenvolupades a un llibre contradueixen les d'algun altre);
 - la presentació d'evidència empírica que les contradigui o avaluï;
 - idees d'altres llibres no seleccionats per a jutjar les idees dels llibres seleccionats.
24. En la tercera secció (que ha de tenir almenys dues pàgines) cal presentar una reflexió personal sobre el que s'ha descrit a les seccions anteriors. Està l'autor de l'assaig d'acord amb les idees principals dels llibres? Disposa d'arguments propis a favor o en contra? Té una visió alternativa a la que defensen els llibres? Tota opinió ha d'estar motivada o justificada amb arguments o informació fàctica. Idealment, es podrien relacionar les idees principals dels llibres amb els continguts del curs (o de cursos relacionats). La secció ha de concloure amb una relació de les principals lliçons extretes de la lectura i l'anàlisi dels llibres.
25. La quarta secció (a titular 'Referències') ha de presentar, seguint les convencions dels treballs acadèmics, totes les fonts bibliogràfiques (llibres, articles, estudis, informes...) citades en les seccions anteriors. La secció ha d'incloure, com a mínim, els llibres seleccionats.
26. Aclariment. No es tracta de llegir cada llibre sencer, sinó d'extreure les idees més importants de manera ràpida. Si n'hi ha, la secció introductòria de cada llibre (i la de conclusions) hauria de contenir la informació útil mínima del llibre. Els títols dels epígrafs han ajudar a identificar les parts més rellevants. Es recomana no dedicar més de dues hores a un llibre d'unes 300 pàgines.
